- Dr. Joe said Spec. ed students need grade level support especially for SBAC.

- 95% of students need to take SBAC so school is not "punished" for opting out.

- Spec. Ed students need extra time on STAR. Not a union issue; need to tell administrator.

- All 4 buildings will have new schedules next year. Middle & HS most likely won't be a

rotating schedule. 2 elem. Schools will have identical schedules.

- Calendar up for approval. No more PD early dis. Days due to chronic absenteeism. Issue with elem. schools & data meetings.
