  - Teacher evaluated and gets "needs improvement" regarding materials yet this is materials from curriculum--- will ask Joe D.

- General:

- CT Case update. Judge has 120 days to come up with their findings. January 3<sup>rd</sup> all parties come together. Official ruling needs to be out by February. This was much longer process than anticipate. <u>Update</u> city asked to go to mediation on Friday. If no agreement it will be decided Feb. 6.
