- Seems extreme for leaving 5 minutes early? Mat said it is our contractual obligation to stay until our contractual time.
- Middle- dress code issues (seems to be taken care of); As professionals we cannot take advantage.
- Mead- Vanessa F. still does not have a laptop. Spoke with superintendent. Tech is working on it. Said it was an oversight on Vinnie's part.
- Prendergast- teacher on structured support at new grade level. The suggestions she was given seemed reasonable. Her plan seems like she is being supported-- Yet, now throwing a lot more at teacher. Is it similar to Mead's structured support plan? Is she being asked to do the same or different as everyone else? Need to make sure administration is doing/helping on their end? Are specialists helping her?
- Intervention issues- upstairs laptop issues. Chromebooks not working. Maybe getting desktops back is necessary. Will buy webcams if needed. Need a better solution to issues. Document what is happening.
 - General- Teachers cannot feel they are a priority when it comes to information (Covid, etc). There is a contract to follow; Teachers do not need to know everything or ALL info. The district has been good with providing info. We are employees. Parents and students are the "customers". They can be told first. We do not need to know first. Those who were affected by previous Covid cases were notified quickly. Others had no need to be notified. Sometimes the less we know, the better. All contract tracing was done; all teachers tested negative. Plan worked like it was supposed to ©
- If you are a teacher under quarantine you can still help each other (get computer, etc); you do not need to use your sick time; yet could work (Under CARE Act)

 the amount of times we're are going to other schools. Also, teachers who wanted
 shields got them.
- Mead- Curriculum starting Sept. 10 instead of 9/21---- again, Steve reiterated to TAKE IT SLOW. Doesn't need to be "perfect". However, getting different message at different schools.
